WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160:

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

### THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2020-290 of the Municipality of Angadanan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

- 1. The utilization of Terminal Leave Benefits in the amount of Three Hundred Nine Thousand Three Hundred Thirty Pesos & 65/100 (P309,330.65) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016, on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
- The payment of Hazard Pay to COVID-19 frontliners in the amount of Five Hundred Thirty Four Thousand Eight Hundred Thirty Five Pesos & 81/100 (P534,835.81) shall be in accordance with DBM Budget Circular No. 2020-1, dated March 24, 2020, on the Guidelines on the Grant of the COVID-19 Hazard Pay;
- 3. The utilization of the appropriation for the project under the 20% Development Fund shall strictly cover only the expenses prescribed and authorized under DILG-DBM Joint Memorandum Circular No. 01 dated March 27, 2020, the Additional Guidelines on the Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment for Development Projects in View of the CORONAVIRUS INFECTIOUS DISEASE 2019 (COVID-19) Situation.

All procurement activities under the 20% Development Fund shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations;

**RESOLVED FURTHER**, to require the Municipality of Angadanan, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.
