WHEREAS, the Provincial Government of Isabela has established a strong partnership with the Department of Interior and Local Government (DILG) in providing former rebels with the necessary aid for their rehabilitation and reintegration as productive citizens of society;

WHEREAS, the Province of Isabela, after careful assessment, was found by the DILG to be qualified and eligible to receive a Financial Assistance worth Five Million Pesos (Php5,000,000.00) under the latter's Enhance Comprehensive Local Integration Program or E-CLIP, to be utilized for the Construction of a Halfway House for Former Rebels and Members of Militia ng Bayan;

WHEREAS, this grant necessitates the execution of a Memorandum of Agreement between the Provincial Government of Isabela and the DILG;

WHEREAS, this Honorable Body acknowledges the benefits and advantages that the Province will gain from the grant, especially in enhancing our capabilities to convince rebels to surrender their armed struggle and reassure them of our commitment in achieving lasting and sustainable peace;

**WHEREFORE**, upon motion of Hon. Faustino U. Dy IV, duly approved and seconded by all the members present in a session duly assembled it was –
