A RESOLUTION SUPPORTING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, IN HIS PURSUIT TO EXTEND AID TO CAVITEÑOS AFFECTED BY THE TAAL VOLCANO ERUPTION, AND ENCOURAGING ISABELEÑOS TO EXHIBIT COMPASSION BY PROVIDING THEM WITH ASSISTANCE

WHEREAS, the picturesque Taal Volcano revealed its destructive side as it erupted on January 12, 2020, prompting mass evacuations within its vicinity;

WHEREAS, the Taal eruption produced a giant ash plume made of hazardous substances and particles which rained down on the Provinces of Batangas and Cavite, and other parts of Luzon;

**WHEREAS,** the ashfall was aggravated by frequent occurrences of volcanic earthquakes with both significantly disrupting social and economic activities within the affected areas;
