WHEREAS, Elvin U. Masigan Integrated Memorial Hospital, a hospital accredited by the Department of Heath, owned and managed LGU Sta. Maria Isabela, seeks the assistance of the PGI to provide logistical support in the transfer of its patients from Milagros Albano District Hospital to Governor Faustino N. Dy Sr. Memorial Hospital, and vice versa;

WHEREAS, this Body recognizes the effort of LGU Sta. Maria to improve the delivery of its health services, and thus agrees to provide them the use of PGI ambulances, subject to limitations provided in the Memorandum of Agreement;

WHEREAS, pursuant to the Local Government Code of 1991, the Provincial Governor is empowered to represent the PGI in all its business transactions and sign in behalf, contracts and obligations, and such other documents;

WHEREFORE, upon motion of Hon. Marco Paolo A. Meris, duly approved and seconded in a session duly assembled it was –
