A RESOLUTION EXPRESSING NO OBJECTION AND DISSENT TO THE PROPOSAL OF UNITED ASSOCIATION OF COCKPIT OWNERS AND OPERATORS OF THE PHILIPPINES INC. TO OPERATE E-SABONG ESTABLISHMENTS IN THE PROVINCE OF ISABELA

WHEREAS, the Provincial Government of Isabela actively promotes the autonomy of local government units while simultaneously extending the necessary assistance and initiatives for their progress, safety, and development;

WHEREAS, cockfighting, or locally known as sabong, is a traditional and legallyrecognized form of recreation and entertainment in the Philippines which caters to a good number of gambling and non-gambling clients;

WHEREAS, with the advent of technological advances in televiewing and online streaming, there now exist a rising market on off-site betting on cockfights – which is termed as E-Sabong;

WHEREAS, E-Sabong televises or streams cockfights outside of the place in which it was licensed to operate – an activity which this Body deems necessary to be regulated;

WHEREAS, the United Association of Cockpit Owners and Operators of the Philippines Inc., (UACOOP), a duly registered association authorized by the Games and Amusements Board to operate E-Sabong establishments, seeks to operate in the Province of Isabela;

WHEREAS, pursuant to pertinent provisions of the Local Government Code, the Sangguniang Panlungsod and Sangguniang Bayan of local government units are granted with the exclusive power and sole authority to issue licenses on the establishment, operation, and maintenance of cockpits, and to regulate cockfighting and commercial breeding of gamecocks within their territorial jurisdictions;

WHEREAS, the Provincial Government of Isabela respects the discretion and authority of local government units in granting UACOOP license to operate in their respective territories and interposes no objection and dissent to the same;

WHEREFORE, premises considered, upon motion of HON. ED CHRISTIAN S. GO, duly approved and seconded in a session duly assembled, it was –

APPROVED, AS IT HEREBY APPROVES, TO ADOPT A RESOLUTION EXPRESSING NO OBJECTION AND DISSENT TO THE PROPOSAL OF UNITED ASSOCIATION OF COCKPIT OWNERS AND OPERATORS OF THE PHILIPPINES INC. TO OPERATE E-SABONG ESTABLISHMENTS IN THE PROVINCE OF ISABELA
