WHEREAS, the Philippines is experiencing an unprecedented health crisis due to the spread and pervasiveness of COVID-19;

WHEREAS, in order to contain the spread of COVID-19, the National Government implemented varying versions of Community Quarantines in the country with the primary aim of restricting the movement of persons which resulted in, among others, the suspension and limiting of public transportation;

WHEREAS, as a consequence of the suspension and limiting of public transportation, many Filipinos, including Isabeleños, were stranded in Metro Manila and other localities:

A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A CONTRACT OF LEASE OF MOTOR VEHICLE WITH DALIN JD TRANSPORT INC. TO AUGMENT THE VEHICLE FLEET OF THE PGI UTILIZED FOR THE HATID PROBINSYA PROGRAM

WHEREAS, many of our fellow Isabeleños have expressed their desire to return to the Province but are unable to do so due to lack of transportation;

WHEREAS, to resolve this transportation predicament, the National Government, with the assistance of local government units including the PGI, implemented the Hatid Probinsya Program with the aim of resolving the transportation needs of Locally Stranded Individuals (LSIs);

WHEREAS, the existing vehicle fleet of the PGI is unable to accommodate all Isabeleño LSIs at an efficient and expeditious rate. Also, delays in providing them with transportation further risks them of exposure to COVID-19. As such, there is an urgent need to augment the vehicle fleet of the PGI in order for our stranded Isabeleños to return home as promptly and as safely as possible;

WHEREAS, the PGI and Dalin JD Transport Inc., a duly registered private entity engaged in the provision of public transportation, desires to enter in a Contract of Lease of Motor Vehicles in which five (5) buses of the latter shall be leased by the PGI for the transportation of Isabeleño LSIs to the Province;

WHEREAS, this Honorable Body finds the consideration for the Contract of Lease of Motor Vehicle with Dalin JD Transport Inc. reasonable, and the purpose of the same beneficial to the Province of Isabela;

WHEREFORE, premises considered, upon motion of Honorable Ed Christian S. Go, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A CONTRACT OF LEASE OF MOTOR VEHICLE WITH DALIN JD TRANSPORT INC. TO AUGMENT THE VEHICLE FLEET OF THE PGI UTILIZED FOR THE HATID PROBINSYA PROGRAM
