RESOLUTION FAVORABLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT THE PROPOSED REHABILITATION OF FLOOD CONTROL PROJECTS WITH DREDGING AND ADDITIONAL RIPRAP IN THE TOTAL AMOUNT OF SIXTY MILLION PESOS (P 60,000,000.00) UNDER THE LOCAL GOVERNMENT SUPPORT FUND-FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA TO LGUS) OF AN WARAY PARTY LIST, REPRSENTED BY HON. FLORENCIO G. NOEL, IN THE FY 2020 GENERAL APPROPRIATIONS ACT (GAA), REPUBLIC ACT NO. 11465

WHEREAS, the Province of Isabela is known as the gateway of most typhoons in the Northern Luzon;

WHEREAS, typhoons or tropical storms may sometimes cause heavy rains resulting to rapid flooding not only in the low lying areas but in the municipalities where drainage systems are not developed or properly maintained;

WHEREAS, to minimize the damaging effects of flooding, there is a need to conduct rehabilitation of flood control projects with dredging and additional riprap to identified municipalities;

WHEREAS, despite being included in the Local Development Investment Program and Annual Investment Program as one of its priority projects, it is constrained by inadequate funds to implement rehabilitation of flood control projects;

WHEREAS, there is need to ask for financial assistance from the AN WARAY PARY LIST, represented by HON. FLORENCIO G. NOEL, through the Local Government Support Fund – Other Financial Assistance to Local Government Units (LGSF-FA to LGUs);

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular No. 122 which provides for the Guidelines on the Release and Utilization of the Local Government Support Fund – Other Financial Assistance to Local Government Units (LGSF-FA to LGUs) in the FY 2020 General Appropriations Act (GAA), Republic Act No. 11465;

WHEREAS, the rehabilitation of flood control projects with dredging and additional riprap are included in the enumerated priority programs and projects which are eligible to be funded under the Local Government Support Fund – Other Financial Assistance to Local Government Units (LGSF FA to LGUs);

WHEREFORE, premises considered, upon motion of HON. ALFREDO V. ALILI, duly seconded and unanimously approved by the members of this August Body, it was-
