THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2019-001 (2019 Supplemental Budget No. 01) of the Municipality of Echague, Isabela OPERATIVE IN ITS ENTIRETY subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- The amount appropriated for Life & Retirement Insurance Premium under the MDRRMO office on page 3 of Appropriation Ordinance No. 2019-002 should be Nineteen Thousand Eight Hundred Pesos (P19,008.00). Typographical errors must be avoided especially in the budget documents which are considered legal documents;
- 2. The grant of Other Personnel Benefits in the amount of Thirty Thousand Pesos (P30,000.00) has no legal basis, hence not allowed;

RESOLVED FURTHER, to require the Municipality of Echague, Isabela to comply with the herein review findings and/or conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Echague, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the Sangguniang Bayan of the Municipality of Echauge, Isabela through the Honorable FRANCIS FAUSTINO A. DY, Municipal Mayor.
