## RESOLUTION NO. 2020-10-9 SERIES OF 2020

A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A CONTRACT OF LEASE WITH MR. VIRGILIO V. BABARAN FOR THE UTILIZATION OF VILLA DIANA HOTEL AND CAFE AS A QUARANTINE FACILITY FOR COVID-19 PUIs and PUMS

WHEREAS, on March 12, 2020, the World Health Organization classified the 2019 Corona Virus Disease (COVID-19) as a pandemic with the virus infecting hundreds of thousands globally and killing thousands, with new cases being reported continually;

WHEREAS, on March 16, 2020, His Excellency, President Rodrigo R. Duterte, issued Presidential Proclamation No. 922, series of 2020, which placed the country under a State of Public Health Emergency due to the rising number of COVID-19 cases in the country;

TO ADDPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A CONTRACT OF LEASE WITH MR. VIRGILIO V. BABARAN FOR THE UTILIZATION OF VILLA DIANA HOTEL AND CAFE AS A QUARANTINE FACILITY FOR COVID-19 PUIS and PUMS

WHEREAS, a day after such Proclamation, President Rodrigo R. Duterte issued Presidential Proclamation No. 929, series of 2020, further placing the entire country under State of Calamity for six (6) months unless earlier lifted or extended as the circumstances may warrant, and imposed an Enhanced Community Quarantine throughout Luzon;

WHEREAS, pursuant to the directive of the President and in fulfillment of its mandate to protect and promote the general welfare of its people, the Provincial Government of Isabela immediately established proactive, preventive, and sustainable measures to avert the spread of COVID-19 in the Province;

WHEREAS, in furtherance of the Province's strict anti-COVID-19 measures, the Provincial Government of Isabela has expressed the need to amplify its efforts in preventing the local spread of the disease, and as such has recognized the immediate necessity to designate quarantine facilities to which COVID-19 PUIs and PUMs will be sheltered in during their quarantine period;

WHEREAS, the site sought to be designated as a quarantine facility must possess the following: located near the Province's border to avert PUI and PUM entry in the Province and allow their ready transfer to a quarantine facility; has reasonable distance to the populace; proximity to medical establishments; and spacious facilities to observe physical distancing;

WHEREAS, Villa Diana Hotel and Cafe satisfies the requirements of strategic location, reasonable distance, proximity, and spacious facilities, and as such is hereby designated as a Quarantine Facility for COVID-19 PUIs and PUMs;

WHEREAS, to effectuate such designation, a Contract of Lease must be entered into by the Provincial Government of Isabela and Mr. Virgilio V. Babaran, owner of Villa Diana Hotel and Cafe:

**WHEREFORE**, upon motion of Honorable Marco Paolo A. Meris, duly approved and seconded by all the members present in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES: TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A CONTRACT OF LEASE WITH MR. VIRGILIO V. BABARAN FOR THE UTILIZATION OF VILLA DIANA HOTEL AND CAFE AS A QUARANTINE FACILITY FOR COVID-19 PUIs and PUMS
