WHEREAS, the Local Government Code duly empowers the Provincial Government of Isabela to create its own source of revenue;

WHEREAS, the same Code, particularly Section 468 thereof, encourages local government units to generate and maximize the use of its resources and revenues, which include the option of leasing government properties to private parties, subject to existing laws, rules, and regulations;

WHEREAS, the Provincial Government of Isabela is the registered owner of a building and a lot situated in the Provincial Capitol Compound, Alibagu, City of Ilagan, Isabela which is being utilized as a Food Court;

WHEREAS, there are parties who manifested their desire to lease stall units in the Food Court;

WHEREAS, this Honorable Body recognizes that aside from the revenue which the Provincial Government of Isabela will receive from rental fees of the leased stall units, authorizing the leasing of units in the Food Court will also create business, employment, and livelihood opportunities for the prospective lessees and their workers – all in accord with the policy and aspiration of the Provincial Government of Isabela to provide its people with the necessary assistance for their growth and development;

WHEREAS, this Honorable Body finds that the Contract of Lease which will be utilized in effecting lease agreements on stall units in the Food Court as reasonable and beneficial to the public. Such Contract of Lease shall form as an integral part of this Resolution;

WHEREFORE, premises considered, upon motion of Hon. Alfredo V. Alili, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA ALL CONTRACTS OF LEASE RELATIVE TO THE LEASING OF STALL UNITS IN THE FOOD COURT OF THE PROVINCIAL CAPITOL COMPOUND, EFFECTIVE FROM JUNE 1, 2020 TO JUNE 30, 2021;
