WHEREAS, Ordinance No. 2020-14 was enacted by the Sangguniang Bayan of the Municipality of Cordon on September 22, 2020\_in consonance to its mandate as provided for under Section 20 of RA 7160 or the Local Government Code of 1991 which provides that:

A city or municipality may, through an ordinance passed by the Sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and

sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the Sanggunian concerned: Provided, That such reclassification shall be limited to the following percentage of the total agricultural land area at the time of the passage of the ordinance;

WHEREAS, Section 56 of the Local Government Code establishes the authority of the Sangguniang Panlalawigan to review city or municipal ordinances for the purpose of determining if such is beyond the power conferred upon the sangguniang panlungsod or sangguniang bayan;

WHEREAS, the Committee on Housing, Subdv. & Land Use Classification, after a thorough review, finds that Ordinance No. 2020-14 of the Municipality of Cordon is in consonance to the mandate of the Sangguniang Panlungsod pursuant to Section 20 of the Local Government Code. Thus, the said Ordinance is within the scope of the powers conferred by law to their Sangguniang Panlungsod;

WHEREAS, the Committee recommended to the August Body to uphold the validity of Ordinance No. 2020-14 of the Municipality of Cordon;

NOW THEREFORE, above premises considered, upon motion of HON. ED CHRISTIAN S. GO, duly approved and seconded in a session duly assembled, it was:
