WHEREAS, Isabela is primarily an agricultural province and is one of the country's prime producers of rice, corn, and other high value crops. As such, it is home to countless farmers and farm workers who rely on farming as means for daily sustenance and livelihood;

WHEREAS, on November 12, 2020, Typhoon Ulysses dropped heavy and prolonged rainfall in Isabela causing extensive floodings across the Province, the submersion of vast agricultural lands, and loss of livelihood to countless farmers;

WHEREAS, recognizing the widespread devastation being caused by Typhoon Ulysses, this Honorable Body, on the same date, promptly conducted a Special Session and passed Resolution No. 2020-40-1 declaring the entire Province of Isabela under a State of Calamity;

A RESOLUTION REQUESTING THE DEPARTMENT OF AGRICULTURE, THROUGH HONORABLE SECRETARY WILLIAM D. DAR, TO EXTEND RELIEF TO THE PROVINCE OF ISABELA'S FARMERS AND ITS AGRICULTURAL SECTOR TO FACILITATE THEIR RECOVERY FROM THE DEVASTATION CAUSED BY TYPHOON ULYSSES

WHEREAS, November 14, 2020 data from the Isabela Provincial Agriculturist Office showed that Typhoon Ulysses caused Php136,987,642.20 worth of damages and losses to Isabela's agricultural sector and affected approximately 8,260 hectares of agricultural lands;

WHEREAS, Isabela's farmers and local agricultural industry are in dire need of immediate socio-economic aid and relief:

WHEREAS, there exist a clear urgency to implement rehabilitative measures for Isabela's severely damaged agricultural sector considering that it is an integral driver of its economy, a key provider of income and livelihood to countless people, and one of the country's biggest sources of agricultural products;

WHEREAS, this Honorable Body implores the Department of Agriculture, through Honorable Secretary William D. Dar, to extend assistance to Isabeleño farmers devastated by Typhoon Ulysses to alleviate their losses and to facilitate their economic recovery;

WHEREFORE, premises considered, upon motion of Hon. Adrian Philip S. Baysac, duly approved and seconded in a motion duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION REQUESTING THE DEPARTMENT OF AGRICULTURE, THROUGH HONORABLE SECRETARY WILLIAM D. DAR, TO EXTEND RELIEF TO THE PROVINCE OF ISABELA'S FARMERS AND ITS AGRICULTURAL SECTOR TO FACILITATE THEIR RECOVERY FROM THE DEVASTATION CAUSED BY TYPHOON ULYSSES;
