A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE FOR THE RECEIPT OF TWO MODULES OF CATTLE FEEDLOT FATTENING PROJECT AMOUNTING TO TEN MILLION PESOS GRANTED UNDER THE STIMULUS PACKAGE FOR AGRICULTURE UNDER THE BAYANIHAN II

WHEREAS, the National Government passed Republic Act No. 11494 or the "Bayanihan to Recover as One Act", or briefly known as Bayanihan II, with the end aim of, among others, reducing the adverse impact of COVID-19 on the socio-economic wellbeing of Filipinos through the provision of assistance, subsidies, and other forms of socio-economic relief;

WHEREAS, the Department of Agriculture received an allocation of 24 Billion Pesos from Bayanihan II. From that allocation, the National Livestock Program was allotted a total of 678 Million Pesos to implement 2 flagship projects, namely: (a) The Nucleus and Multiplier Breeder Farms for Poultry, Swine, and Small Ruminants with a

budget of 500 Million Pesos; and (b) The Cattle Feedlot Fattening Project with a budget of 178 Million Pesos;

WHEREAS, the Province of Isabela is one of the identified beneficiaries of the Cattle Feedlot Fattening Project. Accordingly, the Department of Agriculture has allotted Ten Million Pesos for the implementation of such project in the Province of Isabela;

WHEREAS, the implementation of the Department of Agriculture's Cattle Feedlot Fattening Project in the Province of Isabela requires the execution of a Memorandum of Agreement between their office and the Provincial Government of Isabela;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, considering that the Cattle Feedlot Fattening Project will increase local beef production and availability of affordable beef in the local market thereby providing additional income and livelihood to our local farmers, this Honorable Body unanimously extends its favorable action in granting the Honorable Provincial Governor the requisite authority to enter into the said Memorandum of Agreement with the Department of Agriculture;

WHEREFORE, premises considered, upon motion of Hon. Adrian Philip S. Baysac, duly approved and seconded in a Session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
