WHEREAS, the country is facing an unprecedented health crisis due to the spread and pervasiveness of COVID-19;

WHEREAS, as part of the country's COVID-19 response, the National Government appropriated the amount of Php1,500,000,000.00 to the Local Government Support Fund (LGSF), pursuant to Section 4 (q) of Republic Act No. 11494 or the Bayanihan to Recover as One Act, to be provided as financial assistance to Local Government Units to support their local COVID-19 efforts;

AVISADO, THE REQUEST OF THE PROVINCIAL GOVERNMENT OF ISABELA TO AVAIL FUNDS FROM THE LOCAL GOVERNMENT SUPPORT FUND — COVID-19 FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS IN THE BAYANIHAN TO RECOVER AS ONE ACT IN THE AMOUNT OF FOUR HUNDRED MILLION PESOS (Physiolo,000,000,00) FOR THE CONTINUED IMPLEMENTATION AND ENHANCEMENT OF ITS COVID-19 PROGRAMS AND INITIATIVES

WHEREAS, the Department of Budget and Management issued Local Budget Circular No. 128 which prescribed the guidelines and procedures on the release and utilization of the LGSF-COVID19 Financial Assistance to LGUs;

WHEREAS, the Province of Isabela is experiencing a steady increase of COVID-19 cases as it tallied 295 active cases and 22 new cases as of October 13, 2020 – with hundreds more awaiting their COVID-19 test results in various quarantine facilities established across the Province. Due to such increase, the local medical field is experiencing a rapid depletion in their medical equipment and supplies that are necessary for the extension of quality healthcare and service to patients and most crucially, in equipping themselves of appropriate protection against COVID-19;

WHEREAS, the pandemic also triggered a dispiriting chain reaction in the local economy of the Province as the months-long interruption in the operations of businesses resulted in the loss of investments and in turn, the closure of businesses, big and small, and the displacement of countless workers;

WHEREAS, the Provincial Government of Isabela has implemented a comprehensive response mechanism to effectively respond to the problems brought about by the COVID-19 crisis which include, among others, the Province-wide extension of medicines, vitamins, and immune health supplements; and the provision of appropriate medical equipment and supplies to government hospitals and medical personnel. However, with the pandemic persisting for an extended period, funds of the Provincial Government of Isabela allocated for its COVID-19 response are nearing full exhaustion;

WHEREAS, an interruption in the Province's COVID-19 programs and initiatives will negate any progress that the Provincial Government of Isabela and its people have achieved in the past seven months in trying to resolve this pandemic, and will further worsen the health, social, and economic crises that the Isabeleño populace are currently experiencing;

WHEREAS, the Provincial Government of Isabela aspires to avail monetary assistance from the LGSF-COVID-19 FA to LGUs in the amount of FOUR HUNDRED MILLION PESOS (Php 400,000,000.00) to be utilized for the continued implementation and enhancement of its COVID-19 programs in the following order of priority:
