A RESOLUTION APPROVING THE PROPOSED ACQUISITION OF THE PROVINCIAL GOVERNMENT OF ISABELA OF TWO UNITS BRAND NEW MOTORCYCLE, 700CC MT07, WITH AN ESTIMATED COST OF NINE HUNDRED EIGHTEEN THOUSAND PESOS (PHP918,000.00) TO BE CHARGED AGAINST THE GENERAL FUND — CAPITAL OUTLAY OF THE OFFICE OF THE PROVINCIAL GOVERNOR

WHEREAS, in pursuit of such aspiration, the Provincial Governor, Honorable Rodolfo T. Albano III, sent a Letter to this Honorable Body requesting for the passage of a Resolution approving the acquisition of two (2) units brand new motorcycle, 700 MT-07, with an estimated cost of Nine Hundred Eighteen Thousand Pesos (Php918,000.00) which will be charged against the General Fund — Capital Outlay of the Office of the Provincial Governor;

WHEREAS, the two (2) motorcycles which the Office of the Provincial Governor seeks to acquire have higher engine displacement than those established under Section 4.0 of Department of Budget and Management (DBM) Budget Circular No. 2019-2 in relation to DBM Budget Circular No. 2017-1;

WHEREAS, this Honorable Body finds that the acquisition of the two (2) motorcycles that have higher engine displacement than the DBM-established standards, as provided in the Budget Circulars in the previous clause, is reasonable, justifiable, and consistent with the mandate of the Provincial Government of Isabela to provide and guarantee all of its citizens with vital government assistance and service;

WHEREFORE, premises considered, upon motion of Hon. Faustino U. Dy IV, duly approved and seconded in a session duly assembled it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION APPROVING THE PROPOSED ACQUISITION OF THE PROVINCIAL GOVERNMENT OF ISABELA OF TWO UNITS BRAND NEW MOTORCYCLE, 700CC MT07, WITH AN ESTIMATED COST OF NINE HUNDRED EIGHTEEN THOUSAND PESOS (PHP918,000.00) TO BE CHARGED AGAINST THE GENERAL FUND – CAPITAL OUTLAY OF THE OFFICE OF THE PROVINCIAL GOVERNOR

RESOLVED FURTHER, that the proposed acquisition approved under this Resolution is subject to the review and concurrence of the Department of Budget and Management and other concerned government agencies, and shall be deemed revoked if such agencies fail or refuse to give such concurrence.
