WHEREAS, this Honorable Body passed Ordinance No. 022, series of 2019, which authorized and approved the 2020 Annual Budget of the Provincial Government of Isabela(PGI);

WHEREAS, on March 19, 2021, the Office of the Provincial Governor sent a Letter addressed to this Honorable Body requesting that the allotment class of different accounts under the Economic Development Fund of the Provincial Government of Isabela (PGI) for Fiscal Year 2020 be reclassified from "Maintenance & Other Operating Expenses" to Capital Outlay";

WHEREAS, such accounts pertain to the agricultural programs of the PGI aimed at enhancing the local production of pineapples, tilapia-fingerlings, white corn, dairy products, and rice, and the further development of the respective marketing enterprise of various local government units;

WHEREAS, considering that the implementation and the full realization of the progress of such programs will extend beyond year 2020, there is a need to reclassify their allotment class from "Maintenance & Other Operating Expenses" to "Capital Outlay";

WHEREAS, the enactment of an Ordinance is necessary for the reclassification of accounts to a different allotment class;

WHEREAS, the passage of Ordinance is earnestly sought.

#### **Maintenance and Other Operating Expenses (MOOE)**

AN ORDINANCE RECLASSIFYING THE ALLOTMENT CLASS OF VARIOUS ACCOUNTS UNDER THE ECONOMIC DEVELOPMENT FUND OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR FISCAL YEAR 2020 FROM "MAINTENANCE & OTHER OPERATING EXPENSES" TO "CAPITAL OUTLAY"

Section 2. Reclassification. The various accounts enumerated in Section 1 of this Ordinance is hereby reclassified from **"MAINTENANCE & OTHER OPERATING** EXPENDITURES to **"CAPITAL OUTLAY"**.

Accordingly, the use of funds appropriated to such accounts is hereby authorized to be made beyond the year 2020.

Section 3. Utilization of Funds. The utilization of funds appropriated to such accounts shall strictly adhere to existing and appropriate budgetary, procurement, accounting, and auditing laws, rules and regulations.

Section 4. Effectivity Clause. This Ordinance shall take effect immediately upon approval.
