WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare the Appropriation Ordinance No. 009 S. 2019 (2020 Annual Budget) of the Municipality of Quirino, Isabela **OPERATIVE IN ITS ENTIRETY** effective January 1, 2020, subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

 The following Position Title and Salary Grades should be in accordance with DBM LBC No. 61 dated March 18,1996 on the revised Index of Occupational Services, Position Titles and Salary Grades (IOS) in the Local Government, and DBM BC No. 2004-3 dated March 6, 2004 the Conversion of Positions Performing Staff/Non-Technical Functions, to wit:

2. The MHRMO must reconcile the inconsistency of the Salary Rates, Salary Grades and Step Increment of the following positions in accordance with Salary Schedule Annex "A6" of DBM Local Budget Circular No. 113 dated January 5, 2019:

- 3. That we reiterate our previous review action that the position of Nurse III SG-17/1 under the Municipal Health Office is not in accordance with Section 4(d) of Local Budget Circular No. 53, which states that the highest level of Position below Assistant Department Head shall be allocated to SG 15 for 4th to 6th Class Municipalities. Since the subject position does not conform to the herein prescribed allowable SG allocation, correction shall be effected without diminution in salary of the concerned personnel. However, subsequent salary increase shall be applied only on the correct classified position;
- 4. The position of Dentist II SG-17/8 when becomes vacant shall be downgraded to Dentist I SG-14/1 to conform with the guidelines of Local Budget Circular No. 53.
- 5. This is to reiterate that the position of Driver II/Administrative Aide IV SG-4 under the Municipal Health office shall not be allowed pursuant to the Qualification Standard (Revised 1997) of the Civil Service Commission and the Manual on Position Classification and Compensation Scheme in LGUs. Item 9.2.1.6 under Chapter 9 of the Manual on Position Classification and Compensation Scheme in LGUs states that the classification of Driver position is dependent on the level/rank of the position they serve. Per established standards, the allowable level of the position of Driver II is SG-4 for the Mayor's Office only and for the different offices the position must be Driver I, SG 3. Since the subject position does not conform to the herein prescribed allowable SG allocation, corrections shall be effected without diminution in salary of the concerned personnel. However, subsequent salary increase shall be applied only on the correct classified position;

- 6. The appropriation for PhilHealth Contribution shall be in accordance with DBM Budget Circular No. 2019-8 dated July 8, 2018, on the Employer (Government) Share in the Health Insurance Premium Contributions to the Philippine Health Insurance Corporation Effective FY 2019 and PhilHealth Circular No. 2019-0009 on the Premium Contribution in the National Health Insurance Program (NHIP) Pursuant to RA No. 11223 Known as the "Universal Health Care Act";
- 7. The appropriation for Confidential Expenses in the amount of Five Hundred Thousand Pesos (P500,000.00) shall be governed by the provisions of COA-DBM-DILG-GCG and DND Joint Circular no. 2015-01 dated January 8, 2015;
- 8. The appropriation for Donations under the Municipal Social Welfare and Development Office in the total amount of One Hundred Sixty Five Thousand Pesos (P165,000.00) shall be disallowed. The disposition of the account Donations shall be under the Office of the Mayor. However, appropriations therefrom can be reallocated to another object of expenditures as may be deemed appropriate, either in the same office or another office;
- 9. The appropriation for the following accounts should be properly classified to specific Object of Expenditures and account code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:

10. The utilization of the appropriation for Capital Outlay and Consultancy Services in the amount of One Million Seven Hundred Forty Six Thousand Pesos (P1,746,000.00) and Three Hundred Forty Thousand Pesos (P340,000.00) respectively, must be governed by the provisions of A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 009 S. 2019 (2020 ANNUAL BUDGET) IN THE TOTAL AMOUNT OF ONE HUNDRED TEN MILLION NINE HUNDRED EIGHTY SIX THOUSAND EIGHT HUNDRED EIGHTY SEVEN PESOS (P110,986,887.00) OF THE MUNICIPALITY OF QUIRINO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

Republic Act 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations;

- 11. The appropriations for Local Disaster Risk Reduction Management Fund (LDRRMF) in the amount of Five Million Five Hundred Forty Nine Thousand Three Hundred Forty Four Pesos & 35/100 (P5,549,344.35) shall adhere to the provisions of Republic Act 10121, DILG Memorandum Circular No. 2012-73 dated April 17, 2012 and NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Plan shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its implementing Rules and Regulations supplemented by Local Budget Memorandum No. 78 dated May 15, 2019, copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRMF;
- 12. The appropriation for the 20% Development Fund shall strictly cover only the development projects prescribed and authorized under DILG-DBM Joint Memorandum Circular No. 2017-1 dated February 22, 2017.

Further, the following project is disallowed:

1. Procurement of One (1) Unit Set Standby Generator-Three Phase Connection for P2,000,000.00

Said project is not covered by said JMC, however, same can be reappropriated in the General Fund Account provided the no less than 20% requirement for EDF shall be observed, or can be re-programmed with programs/projects activities covered by said Joint Memorandum Circular.

All projects under the 20% Development Fund shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Quirino, Isabela to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED FURTHER, to furnish the Municipality of Quirino, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting rules and regulations.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of the Municipality of Quirino, Isabela through the **Honorable EDWARD D. JUAN**, Municipal Mayor.
