WHEREAS, for such purpose, the Office of the Provincial Governor sent a Letter addressed to this Honorable Body expressing his desire to be provided with the requisite authority to enter into a Deed of Usufruct with the Bureau of Fire Protection Region 02;

WHEREAS, this Honorable Body considers this endeavor of the Provincial Governor as beneficial to the Isabeleño populace and consistent with the policy of the Provincial Government of Isabela to promote the safety and enhance the well-being of its people;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;
