A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ISABELA STATE UNIVERSITY FOR THE IMPLEMENTATION OF PROJECT S&T BASED REHABILITATION OF DAMAGES CAUSED BY TYPHOON ULYSSES AND THE WIDESPREAD FLOODING IN ISABELA PROVINCE

WHEREAS, in November 2021, Typhoon Ulysses crossed over the country and brought heavy rains in the provinces of Isabela and Cagayan;

WHEREAS, due to heavy rains brought about by Typhoon Ulysses, Magat Dam was forced to release water which caused the abrupt increase of water level in Cagayan River and eventually resulted to heavy flooding and temporary displacement of communities;

WHEREAS, the Department of Science and Technology - Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development of the (DOST-PCAARRD) has developed a more sustaining proactive emergency response program known as the Science and Technology (S&T) Action Frontline for Emergencies and Hazards (SAFE);

WHEREAS, the Isabela State University is implementing S&T intervention designed to support the provision of necessary services and facilities that would address the impacts of typhoon Ulysses and the widespread flooding in the heavily devastated communities in the province;

WHEREAS, the Provincial Government of Isabela, being the government agency with primary jurisdiction of ensuring the safety of Isabeleños, aims to determine and identify the effects of climate change for it to be able to immediately address the needs of its constituents in times of calamities or disasters;

WHEREAS, there is a need to enter into a Memorandum of Agreement to collaborate with ISU in the implementation of the project S&T Based Rehabilitation of Damages Caused by Typhoon Ulysses and the Widespread Flooding in the Province of Isabela;

WHEREAS, Section 465(I)(vi) of the LGC empowers the Provincial Governor to represent the Provincial Government in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, upon careful review of the Memorandum of Agreement, this Body deems it beneficial to the interests of both parties to confer the Provincial Governor the necessary authority to enter into a Memorandum of Agreement with Isabela State University;

WHEREFORE, upon motion of the Hon. Alfredo V. Alili, duly seconded and approved of all the members present in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES: TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
