**RESOLVED**, to declare Appropriation Ordinance No. 2020-010 of the Municipality of Jones, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

 The appropriation for the Bayanihan Grant to Cities/Municipalities (BGCM) shall exclusively be used on the projects prescribed and authorized under DBM Local Budget Circular No. 125 dated April 7, 2020, the Guidelines on the Release and Utilization of the BGCM.

> All procurement activities under the BGCM shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of Jones, Isabela to comply with the herein review findings and/or conditions;

**RESOLVED FURTHER**, to inform the Municipality of Jones, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations;

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the Sangguniang Bayan of the Municipality of Jones, Isabela through the **Honorable LETICIA T. SEBASTIAN**, Municipal Mayor.
