THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 20-003 of the Municipality of Roxas, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following condition:

 The utilization of the appropriation for the projects under the 20% Development Fund shall strictly cover only the expenses prescribed and authorized under DILG-DBM Joint Memorandum Circular No. 01 dated March 27, 2020, the Additional Guidelines on the Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment for Development Projects in View of the CORONAVIRUS INFECTIOUS DISEASE (COVID-19) Situation.

All procurement activities under the 20% Development Fund shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations and COA-GPBB JMC NO. 1 dated March 26, 2020, the Emergency Procurement by the Government During a State of Public Health Emergency Arising from the Corona Virus Disease 2019 (COVID-19)

RESOLVED FURTHER, to require the Municipality of Roxas, Isabela to comply with the herein conditions;

RESOLVED FURTHERMORE, to inform the Municipality of Roxas, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations;

RESOLVED FINALLY, to furnish a copy of this Resolution to the Sangguniang Bayan of the Municipality of Roxas, Isabela through the **Honorable JONATHAN JOSE C. CALDERON**, Municipal Mayor.
