WHEREAS, with the surge of the number of COVID-19 cases within the Province, there is a need to procure Personal Protective Equipment and other medical supplies and logistics in response to COVID-19 to ensure the safety of health care workers and to sustain the intensive response and operations of referral hospitals, health facilities, laboratory and quarantine facilities in the region;

WHEREAS, as the Provincial Government of Isabela (PGI) recognizes the need to procure PPEs, other medical supplies and logistics to sustain its intensive response to the COVID-19 pandemic, an execution of a Memorandum of Agreement between the PGI and CVCHD is indispensable for the same;

WHEREAS, Section 465 (b) (vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T.
