**WHEREAS**, one of the policies of the Provincial Government of Isabela (PGI) is to prioritize the health and well-being of the vulnerable and underprivileged;

**WHEREAS**, health is one of the priorities in the Philippine Development Plan consistent with the health-related Sustainable Development Goals;

**WHEREAS**, consonant to the Philippine Development Plan in giving priority to health-related Sustainable Development Goals, the PGI is committed and desirous to engage with the National Government in order to realize and promote their respective mandates and shared goals;

**WHEREAS**, the Office of the Provincial Governor sent a Letter to the Sangguniang Panlalawigan requesting this Honorable Body to grant Honorable Rodolfo T. Albano III with authority to represent and bind the PGI in a Memorandum of Agreement (MOA) with the Office of the President for the monthly allocation of P5,000,000.00, subject to replenishment, to the Governor Faustino N. Dy Memorial Hospital, to further strengthen its medical services, especially to the vulnerable and disadvantaged patients in the Province of Isabela;

**WHEREAS**, Section 465(I)(vi) of the Local Government Code empowers the Provincial Governor to represent the Provincial Government in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

**WHEREAS**, after careful review of the Memorandum of Agreement, this August Body deems it beneficial to the interests of both parties, and hereby confers upon the Provincial Governor the requisite Authority to sign in behalf of the PGI the MOA with the Office of the President;

**WHEREFORE**, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded by all the members present in a session duly assembled it was –
