WHEREAS, it is the mandate of the Department of Health (DOH) to provide assistance to local government units in effectively implementing programs, projects, and services for the provision of health care services to every Filipino;

WHEREAS, Republic Act No. 11223 known as the Universal Health care Act of 2019 provides that the DOH shall deploy health workforce under the National Heath Workforce Support System to augment human resource needs in public health systems;

WHEREAS, pursuant to the mandate set forth in its Post-Residency Deployment Service Program, the DOH aspires to deploy a physician in the Governor Faustino N. Dy Sr. Memorial Hospital, in the person of Dr. Ampty T. Vinarao of Dr. Jose R. Reyes Memorial Medical Center, to augment the medical human resource requirement in the province;

WHEREAS, the implementation of the Post-Residency Return Service Program and the deployment of physicians to hospitals operated by the Provincial Government of Isabela necessitates the execution of a Memorandum of Agreement;

WHEREAS, Section 465 of the LGC empowers the Provincial Governor to represent the Provincial Government in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, this Body acknowledges the benefits and advantages that the Province will gain, particularly in ensuring the availability of health professionals and the expansion of its medical initiatives, in the deployment of Dr. Ampty T. Vinarao in the Governor Faustino N. Dy Sr. Memorial Hospital and as such extends its concurrence to the proposed Memorandum of Agreement;
