**A RESOLUTION ADOPTING THE REGIONAL NUTRITION COMMITTEE (RNC) RESOLUTION NO. 02 SERIES OF 2020, KNOWN AS ENJOINING ALL LOCAL GOVERNMENT UNITS TO STRENGTHEN THE INTEGRATION OF NUTRITION PROGRAMS, PROJECTS AND ACTIVITIES IN THEIR 2021-2022 ANNUAL INVESTMENT PROGRAMS TO PREVENT WORSENING OF NUTRITION SITUATION AMID COVID-19 PANDEMIC AND SUPPORTING ITS IMPLEMENTATION IN THE PROVINCE OF ISABELA**

**WHEREAS**, the Provincial Government of Isabela (PGI) adheres to the policy of the State to protect and promote the right to health of the people and to instill health consciousness among them;

**WHEREAS**, to ensure timely and appropriate delivery of nutrition intervention to affected population in times of emergencies, the local nutrition committees of each local government units was designated as the local nutrition clusters;

**WHEREAS**, as a local nutrition cluster, it is the duty of the PGI to support the RNC in fulfilling the cluster's mission, assist in building capabilities among inter and intra-cluster members, and to identify and promote core advocacy concerns;

**WHEREAS**, during this time of COVID-19 pandemic, it has been recognized that nutritional status of individuals is very important in establishing good immune system for our body's protection against the virus or any other infection;

**WHEREAS**, on December 10, 2020, the Regional Nutrition Committee convened and approved RNC Resolution No. 02 s. 2020 otherwise known as *Enjoining All Local Government Units to Strengthen the Integration of Nutrition Programs, Projects, and Activities in their 2021-2022 Annual Investment Programs to Prevent Worsening of Nutrition Situation Amid COVID-19 Pandemic*;

**WHEREAS**, the said resolution recognizes that malnutrition and other comorbidities are contributing factors to complications in people with COVID-19 if the immune system is compromised, hence, the need to strengthen the nutrition program of all local government units in the region;

**WHEREAS**, in line with the PGI's role in promoting the right to health of every Isabeleño, this Body recognizes the need to support and adopt the Regional Nutrition Committee Resolution No. 02 s. 2020 taking into consideration the threat to the nutritional status of Isabeleños especially to vulnerable groups such as infants, children, pregnant and lactating women, and elderly persons during this COVID-19 pandemic and other emergencies;

**WHEREFORE**, premises considered, upon motion of Hon. Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled it was –
