WHEREAS, various countries and private entities are engaged in the development of safe and effective vaccines against COVID-19, among which is the Novavax, Inc., a biotechnology company based in Maryland, USA that has developed a vaccine candidate which it named as "NVX-CoV2373";

WHEREAS, NovaVax has partnered with the Serum Institute of India Private Limited and Serum Life Sciences Limited for the mass production of the NVX-CoV2373 and its immediate availability in the global supply chain;

WHEREAS, Faberco Life Sciences, Inc. is the duly appointed and duly recognized distributor of NVX-CoV2373 in the Philippines;

WHEREAS, the Provincial Government of Isabela, in fulfillment of its mandate to safeguard the health and safety of its people, is eager to conduct mass COVID-19 vaccinations for the immediate resolution of the ongoing pandemic;

WHEREAS, the Provincial Government of Isabela is desirous to obtain doses of NVX-CoV2373 for its local mass COVID-19 vaccination campaign;

WHEREAS, the National Task Force Against COVID-19 (NTF-COVID19) is the lead agency in the implementation of the policies, rules, and regulations issued by the National Government to address and resolve the COVID-19 pandemic;

WHEREAS, the acquisition of COVID-19 vaccines and the conduct of COVID-19 vaccinations require the approval of the NTF-COVID19;

WHEREAS, to facilitate the process of acquiring NVX-CoV2373 doses, the Provincial Government of Isabela aspires to enter into an Agreement with the NTF-COVID19, the Department of Health, and Faberco Life Sciences, Inc.;

WHEREAS, presented for consideration of this Honorable Body is the proposed Agreement between the Provincial Government of Isabela, NTF-COVID19, the Department of Health, and Faberco Life Sciences, Inc. for the acquisition of NVX-CoV2373 doses;

WHEREAS, this Honorable Body finds the Agreement to be just, reasonable, lawful, and in line with the campaign of the Provincial Government of Isabela and the National Government to resolve the COVID-19 pandemic;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Honorable Faustino U. Dy IV, duly approved and seconded in a session duly assembled, it was –
