### **ORDINANCE NO. 2022-27-01 SERIES OF 2022**

**AN ORDINANCE REPROGRAMMING THE AMOUNT OF TEN MILLION ONE HUNDRED SIXTY EIGHT THOUSAND PESOS (PHP10,168,000.00) FROM THE CAPITAL OUTLAY OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR FISCAL YEARS 2018 TO 2020 TO THE ITEMS "TEXT BLAST MACHINE" AND "OTHER LAND IMPROVEMENT"**

**WHEREAS**, presented for the approval of this August Body is a Letter from the Provincial Governor, the Honorable Rodolfo T. Albano III, requesting that the amount of Php10,168,000.00 from the Capital Outlay of the Provincial Government of Isabela for the years 2018 to 2020 be reprogrammed for the acquisition of a Text Blast Machine and Other Land Improvement;

**WHEREAS**, funds under the Capital Outlay may be utilized beyond the fiscal year in which the budget ordinance authorizing its appropriation was enacted. Accordingly, the utilization of funds under this allotment class is proper until such time that the program, project, or activity (PPA) to which they were appropriated is completed, that the continuation thereof is identified by the appropriating agency to be impractical or disadvantageous, or that such funds or unexpended amounts thereof are determined to be better utilized for other PPAs;

**AN ORDINANCE REPROGRAMMING THE AMOUNT OF TEN MILLION ONE HUNDRED SIXTY EIGHT THOUSAND PESOS (PHP10,168,000.00) FROM THE CAPITAL OUTLAY OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR FISCAL YEARS 2018 TO 2020 TO THE ITEMS "TEXT BLAST MACHINE" AND "OTHER LAND IMPROVEMENT"**

**WHEREAS**, Section 305(a) of the Local Government Code provides that *"no money shall be paid out of the local treasury except in pursuance of an appropriations ordinance or law"*;

**WHEREAS**, this August Body acknowledges that for the requested reprogramming of funds and its utilization to be made lawful, an ordinance for such purpose must be enacted;

**WHEREAS**, considering that prompt and accurate information dissemination is vital in the promotion of public order and public safety and that the acquisition of a Text Blast Machine ensures the speedy circulation of crucial and informative government announcements to the people, this August Body hereby approves the aforesaid request of the Provincial Governor;

**WHEREFORE**, this August Body hereby enacts this Ordinance.

**Section 1. Coverage.** This Ordinance shall cover the items specifically provided in Section 2 of this Ordinance.
