AN ORDINANCE REPROGRAMMING A PORTION OF THE 20% ECONOMIC DEVELOPMENT FUND OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR FISCAL YEAR 2022 AMOUNTING TO SIXTEEN MILLION NINE HUNDRED TWENTY FIVE THOUSAND EIGHT HUNDRED EIGHTY SIX PESOS AND 28/100 (PHP16,925,886.28) DERIVED FROM THREE (3) PROJECTS TO FINANCE THE IMPLEMENTATION OF THE CONSTRUCTION/CONCRETING OF PALAWAN BRIDGE AND TWO (2) SLOPE PROTECTION PROJECTS

WHEREAS, submitted for the review of this August Body is a letter signed by the Provincial Governor, the Honorable Rodolfo T. Albano III, requesting that the amount of Php16,925,886.28 appropriated to (3) PPAs in the 20% EDF of the PGI for FY 2022 be reprogrammed to three infrastructure PPAs in the same fund;

WHEREAS, the 10th Sangguniang Panlalawigan passed Resolution No. 2021-23-05 which approved the Annual Investment Plan of the PGI for FY 2022;

WHEREAS, the 8th whereas clause of the said resolution states that “the Provincial Governor may augment or reprogram any item in the approved 20% Economic Development Fund for the year 2022 amounting Php962,805,631.00 from savings in other items within the same appropriation to appropriately mobilize resources to align the development plan with current development issues necessary for the effective implementation of plans, programs, and projects of the Province as contained in the Annual Investment Plan of the Provincial Government of Isabela for FY 2022”;

WHEREAS, in view of the authority granted to the Provincial Governor to reprogram items in the 20% EDF for the year 2022 and the determination of this August Body that such reprogramming promotes the attainment of the development goals of the Provincial Government of Isabela and the resolution of development issues in the Province, this August Body deems the herein reprogramming to be lawful and proper;

WHEREFORE, the immediate approval of this Ordinance is sought.


