WHEREAS, the General Manager of ISELCO 1, Engr. Virgilio L. Montano, has retired on January 05, 2022 upon reaching the age of sixty-five (65) years of age thereby leaving the position of General Manager as vacant;

WHEREAS, the Board of Directors appointed Atty. Catherine May L. Alberto-Rosete, the Manager of the Energy Trading Services Department, Data Protection Officer and Consultant on Special Issues, as Officer-in-Charge General Manager;

WHEREAS, the position of General Manager in every electric cooperative plays an important role in formulating policies relative to the its conduct or service operation. As such, it is urgent and imperative to appoint a qualified General Manager to promote the general welfare and interest of the member-consumer-owners;

WHEREAS, considering the importance of appointing a General Manager, there is a need to declare position of the General Manager as vacant and to convene the selection board who shall appoint a General Manager;

WHEREAS, this Honorable Body deems it proper to assert its mandate to uphold, protect and promote the general welfare of the member-consumer owners in the Province of Isabela especially in this times of pandemic;
