WHEREAS, the position of Provincial Government Department Head (Provincial Cooperatives Development Officer) at the Provincial Cooperative, Livelihood, and Enterprise Development Office of the Provincial Government of Isabela is vacant;

WHEREAS, submitted for the confirmation of this Honorable Body is the appointment papers of Mr. Ric Justice E. Angobung, duly signed by the Honorable Governor Rodolfo T. Albano III, as Provincial Government Department Head (Provincial Cooperatives Development Officer) of the Provincial Government of Isabela to head its Provincial Cooperative, Livelihood, And Enterprise Development Office;

WHEREAS, this Honorable Body acknowledges the authority of the Provincial Governor to appoint officials and employees under the executive department as provided under Section 465(1)(v) of the Local Government Code, subject to limitations provided by relevant laws, rules, and regulations;

WHEREAS, Section 463(d) of the Local Government Code provides that appointment of heads of departments and offices of the provincial government require the concurrence of the majority of all the sangguniang panlalawigan members;

WHEREAS, this Honorable Body upholds its policy that individuals to be appointed to department head positions in the Provincial Government of Isabela must be competent, and possesses all qualifications and none of the disqualifications of the position in which he or she is appointed;

WHEREAS, after careful perusal of the qualifications and competence of Mr. Ric Justice E. Angobung, this Honorable Body finds him to be qualified to head the Provincial Cooperative, Livelihood, And Enterprise Development Office of the Provincial Government of Isabela;

WHEREFORE, upon motion of Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –
