ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) ALL DOCUMENTS PERTINENT TO THE LEASE AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES (LBP), INCLUDING THE TERM SHEET AND CONTRACT OF LEASE OF SUCH AGREEMENT, COVERING FIVE (5) PROPERTIES OWNED BY THE LATTER LOCATED IN ECHAGUE, ISABELA TO BE UTILIZED AS PALAY WAREHOUSES, AND FOR THIS PURPOSE FURTHER GRANTING THE HONORABLE PROVINCIAL GOVERNOR WITH AUTHORITY TO REPRESENT THE PGI IN ALL THE PHASES OF TRANSACTION THEREOF AND TO NEGOTIATE SUCH TERMS AND CONDITIONS EQUITABLE TO THE PGI

WHEREAS, in line with this approach, the Provincial Government of Isabela actively develops and identifies strategies that will improve the quality of the harvest of its farmers, enhance their socio-economic competitiveness, and ensure them of good returns for their food production efforts;

WHEREAS, this Honorable Body acknowledges the importance of having ample storage facilities in the rice production process as it is pivotal in ensuring the quality of palay before it is introduced to the market;

WHEREAS, submitted for the consideration of this Honorable Body is a Letter from the Provincial Governor, Honorable Rodolfo T. Albano III, requesting that he be granted with authority to sign on behalf of the Provincial Government of Isabela all documents necessary to secure the lease of five (5) properties owned by the Land Bank of the Philippines located in Echague, Isabela which shall be utilized as warehouses for palays produced by local farmers;

WHEREAS, accompanying such Letter is a copy of the Term Sheet involving such lease of properties with the Land Bank of the Philippines, and two (2) valid IDs of the Provincial Governor in which he affixed therein his original signatures which are duly authenticated by this Honorable Body;

WHEREAS, after careful review of the Terms and Conditions provided in the Term Sheet, this Honorable Body finds that the same are lawful and favorable to the Provincial Government of Isabela, in line with its socio-economic upliftment policies for its farmers, and augments the number of palay warehouses in the Province thereby improving food production in Isabela;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of Honorable Alfredo V. Alili, duly approved and seconded in a session duly assembled, it was –
