A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER, SIGN AND EXECUTE A MEMORANDUM OF UNDERSTANDING FOR THE SEASONAL AGRICULTURAL SECTOR DEVELOPMENT EXCHANGE PROGRAM WITH JINAN COUNTY, SOUTH KOREA

WHEREAS, through the Seasonal Agricultural Sector Development Exchange Program, the Provincial Government of Isabela (PGI) will find qualified participating farmers who will meet the minimum agricultural competencies, skills, requirements and qualifications as proposed by Jinan County, South Korea while the latter agreed to conduct vocational adaptation orientations and provide decent and stable conditions of the program farmers thereof;

WHEREAS, the PGI shall also extend assistance and cooperation in ensuring all program farmers will safely return to their homes upon the completion of the aforesaid Program;

WHEREAS, availing the Seasonal Agricultural Sector Development Exchange Program and its implementation requires the execution of a Memorandum of Understanding between the PGI and Jinan County, South Korea;

WHEREAS, under Section 465, (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Understanding on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was —
