ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA ALL DOCUMENTS NECESSARY FOR THE EFFECTIVE AND EFFICIENT IMPLEMENTATION OF ALL PRDP PROJECTS AND PROGRAMS IN THE PROVINCE OF ISABELA**

**WHEREAS**, it is the policy of the State to promote industrialization and full employment based on sound agricultural development and agrarian reform, through industries that make full and efficient use of human and natural resources, and which are competitive in both domestic and foreign markets;

**WHEREAS**, in pursuit of these goals, the National Government, through the Department of Agriculture, implemented the Philippine Rural Development Project (PRDP);

**A RESOLUTION REAFFIRMING THE COMMITMENT OF THE PROVINCIAL GOVERNMENT OF ISABELA TO PARTICIPATE IN THE DEPARTMENT OF AGRICULTURE – PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP) THEREBY AUTHORIZING FOR THIS PURPOSE THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA ALL DOCUMENTS NECESSARY FOR THE EFFECTIVE AND EFFICIENT IMPLEMENTATION OF ALL PRDP PROJECTS AND PROGRAMS IN THE PROVINCE OF ISABELA**

**WHEREAS**, the PRDP is a national project under the Department of Agriculture (DA) that aims to establish a modern, value-chain oriented, and climate-resilient agriculture and fisheries sector. It is jointly funded by the World Bank, the National Government and the Local Government Units (LGUs);

**WHEREAS**, with the cooperation of LGUs and the private sector, PRDP provides key infrastructure, facilities, technology and information to raise incomes, productivity and competitiveness in targeted areas;

**WHEREAS**, the Provincial Government of Isabela has been resolute in its efforts to further the National Government's endeavor to promote food security and to raise the quality of life of Filipinos in the countryside. As such, the PGI has consistently supported all the projects and programs of the National Government pertaining to the development of the agricultural sector and the upliftment of rural communities among which is the PRDP;

**WHEREAS**, the National Government obtained a loan from the International Bank for Reconstruction and Development (IBRD), specifically under Loan Agreement for IBRD Loan No. 8421-PH dated September 8, 2014, in an amount equivalent to **Five Hundred One Million Two Hundred Fifty Thousand US Dollars (US\$501,250,000.00)** for the purpose of part-financing the **Philippine Rural Development Project (PRDP)** to support its efforts to reduce poverty among its rural communities in eighty one (81) provinces, and another loan from the IBRD in the amount of **One Hundred And Seventy Million US Dollars (\$170,000,000)**, under Loan Agreement for IBRD Loan No. 8816-PH dated March 2, 2018, for the purpose of providing additional financing to scale up the PRDP;

**WHEREAS**, the IBRD approved the Second Additional Financing ("AF-2"), with IbrD Loan Number 9271-PH, amounting to **Two Hundred Eighty Million US Dollars (\$280,000,000.00)**, which will be utilized to further scale up and support the National Government's efforts to reduce poverty and to ensure economic recovery and strong agricultural value chain in response to the COVID-19 pandemic;

**WHEREAS**, in line with its commitment to support and participate in the PRDP, the Provincial Government of Isabela hereby restates its stand to take part, participate, and cooperate in the implementation of the PRDP and to provide monetary equity to ensure the effective and efficient execution of PRDP projects, subprojects, and programs in the Province of Isabela. Consistent with this, the Provincial Government of Isabela has forwarded to the Department of Agriculture all pertinent documentary requirements for its various proposed subprojects under the PRDP;

**WHEREFORE**, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was –

**(PRDP) THEREBY AUTHORIZING FOR THIS PURPOSE THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA ALL DOCUMENTS NECESSARY FOR THE EFFECTIVE AND EFFICIENT IMPLEMENTATION OF ALL PRDP PROJECTS AND PROGRAMS IN THE PROVINCE OF ISABELA**

**RESOLVED FURTHER**, to authorize the incumbent Provincial Governor, **HONORABLE RODOLFO T. ALBANO**, or his successor, for and on behalf of the Province of Isabela, to undertake the following:

- a. To apply, negotiate, enter into contract, execute, sign implementation management agreements and other documents for subproject implementation with the Department of Agriculture, for the implementation of various subprojects, including amendments, renewal and/or extension thereof under such terms and conditions as may be agreed upon by DA under PRDP;
- b. To issue an Executive Order (EO) creating the Provincial Project and Management and Implementation Unit (PPMIU);
- c. To enter into the contract with the winning bidder for civil works, consultancy and procurement of goods/equipment and other agreements required to be done;
- d. To undertake all acts necessary for the effective implementation of the proposed subproject.

**RESOLVED FURTHERMORE**, to authorize the incumbent Provincial Governor, **HONORABLE RODOLFO T. ALBANO**, or his successor, for and on behalf of the Province of Isabela, to affirm and undertake the following commitments required by PRDP:

- a. To appropriate equity required of the subproject in accordance with the Implementation Management Agreement (IMA) signed by the LGU and DA;
- b. To appropriate and/or allocate additional funds necessary for the efficient and effective implementation including operational and maintenance costs of the completed subprojects;
- c. To provide office space, supplies and materials, equipment and vehicles for the efficient supervision and monitoring of the subproject/s.

**RESOLVED FINALLY**, that a copy of this Resolution be furnished to the Provincial Governor, Honorable Rodolfo T. Albano III, and the Provincial Planning and Development Coordinator, Atty. Eduardo R. Cabantac, EnP, for their information, guidance, and appropriate action.
