A RESOLUTION UPHOLDING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 10-2021 OF THE MUNICIPALITY OF LUNA, ISABELA, ENTITLED, "AN ORDINANCE RECLASSIFYING THE PROPERTY PURCHASED BY JEM SHEIN VERDEJO CRISOSTOMO, LOCATED AT BARANGAY MAMBABANGA, LUNA, ISABELA COVERING AN AREA OF FOURTEEN THOUSAND THREE HUNDRED FIFTY SQUARE METERS (14,350 SQ. M.) FROM AGRICULTURAL TO COMMERCIAL/INDUSTRIAL AND RESIDENTIAL PURPOSES"

WHEREAS, Section 20 (a) of R. A. 7160 or the Local Government Code of 1991 grants a municipality the power to authorize the reclassification of agricultural lands into a residential, commercial or industrial purposes and was more specifically stated as follows:

"A city or municipality may, through an ordinance passed by the sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in

the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the sanggunian concerned."

WHEREAS, on December 07, 2021, Municipal Ordinance No. 10-2021 was enacted by the Sangguniang Bayan of Luna, Isabela, reclassifying a lot covered by TCT nos. T-019300, T-019313, and T-401342 situated at Barangay Mambabanga, Luna, Isabela, with a total lot area of 14,350 square meters, more or less;

WHEREAS, Section 3 of the Memorandum Circular No. 54, Series of 1993, of the Office of the President provides that, "All ordinances authorizing the reclassification of agricultural lands shall be subject to the review and approval by the province in the case of component city or municipality";

WHEREAS, having been authorized to review ordinances reclassifying agricultural lands under the abovesaid Memorandum Circular, the Committee on Housing, Subdivision and Land Use Classification conducted a thorough review of Ordinance No. 10-2021 of the Municipality of Luna and finds the same to be in consonance to the mandate of the Sangguniang Bayan pursuant to Section 20 of R.A. No. 7160. Thus, said ordinance is within the purview of the powers conferred by law to their Sangguniang Bayan;

WHEREAS, the Committee recommended to the Body to uphold the validity of Ordinance No. 10-2021 of the Municipality of Luna, Isabela;

WHEREAS, premises considered, upon motion of HON. ED CHRISTIAN S. GO, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION UPHOLDING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 10-2021 OF THE MUNICIPALITY OF LUNA, ISABELA, ENTITLED, "AN ORDINANCE RECLASSIFYING THE PROPERTY PURCHASED BY JEM SHEIN VERDEJO CRISOSTOMO, LOCATED AT BARANGAY MAMBABANGA, LUNA, ISABELA COVERING AN AREA OF FOURTEEN THOUSAND THREE HUNDRED FIFTY SQUARE METERS (14,350 SQ.
