A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION FOR THE ESTABLISHMENT OF THE LATTER'S RICE PROCESSING SYSTEM 2 PROJECT IN THE PROVINCE OF ISABELA

WHEREAS, the PhilMech offers a rice productivity enhancement project named as Rice Processing System 2 (RPS) 2 in which rice farmers are provided access to multistage rice mills and recirculating driers;

WHEREAS, in line with the above-stated policy, the Provincial Government of Isabela forwarded to PhilMech its intention to avail their Rice Processing System 2 (RPS 2) Project;

WHEREAS, submitted for the consideration of this Honorable Body is the draft Memorandum of Agreement between the Provincial Government of Isabela and PhilMech for the establishment of the RPS 2 Project in the Province of Isabela in which Multi-Stage Rice Mills and Recirculating Driers will be made available for the use of local rice farmers;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, after careful review of the submitted Memorandum of Agreement, this Honorable Body finds the same to be lawful and consistent with the policies of the Provincial Government of Isabela on the enhancement of the economic conditions, productivity, and competitiveness of local farmers hence beneficial to the Province;

WHEREFORE, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
