WHEREAS, Joint Memorandum Circular No. 2020-1 issued by the Department of Agriculture, Department of Budget and Management, and the National Tobacco Administration prescribes the guidelines for the allocation, release, and utilization of the shares of LGUs from the revenues from tobacco excise taxes collected in years 2018 and 2019;

WHEREAS, pursuant to RA 8240, as amended by RA 10351, and DBM Local Budget Memorandum Nos. 83 and 84, the Provincial Government of Isabela (PGI) is entitled to a share in Burley and Native Tobacco Excise Taxes collected in the years 2018 and 2019 in the amount of Php438,979,312.00;

WHEREAS, the Provincial Development Council (PDC) submitted before this August Body, for its approval and consideration, PDC Resolution No. 02, series of 2022 which endorsed the Supplemental Annual Investment Plan of the Provincial Government of Isabela for Fiscal Year 2022 outlining programs, projects, and activities to be funded from its share in the Burley and Native Tobacco Excise Tax Collections for Fiscal Years 2018 and 2019;

WHEREAS, as provided in the said Supplemental Annual Investment Plan, the PGI aspires to utilize such share as follows:
