WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

### THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 08-2021 of the Municipality of Burgos, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

- That the Fifty Eight Million Three Hundred Eighty Eight Thousand One Hundred Forty Six Pesos & 20/100 (P58,388,146.20) loan of the Municipality of Burgos, Isabela, must be governed by Sec. 324 (b) of RA 7160, which states:
  - "That the amount of Appropriations for debt servicing shall not exceed twenty percent (20%) of the regular income of the LGU concerned."
- 2. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations. Further, the acquisition Construction and Heavy Equipments in the amount of Twenty Two Million Three Hundred Ninety Five Thousand Pesos (P22,395,000.00) shall be subject to the provisions of Budget Circular No. 2019-3 dated May 16, 2019 and Administrative Order No. 14 dated December 10, 2019;

**RESOLVED FURTHER**, to require the Municipality of Burgos, Isabela to comply with the herein conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Burgos, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the Sangguniang Bayan of the Municipality of Burgos, Isabela through the **Honorable RUBEN A. GRAGASIN**, Municipal Vice Mayor, and **Honorable KERVIN FRANCIS G.UY**, Municipal Mayor.
