A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 15-2022 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF MALLIG, ISABELA AS INTRA VIRES

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sangguniang of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian";

WHEREAS, presented before this Honorable Body is Municipal Ordinance No. 15-2022 of the Municipal Local Government Unit of Mallig, Isabela (MLGU Mallig) titled "Ordinance Authorizing the Proposed Borrowing of the Municipality of Mallig, Province of Isabela, in the Amount of Sixty-Nine Million Pesos (P69,000,000.00) for the Construction of Level III Water Systems and to Finance the Equity Portion for the Philippine Rural Development Program (PRDP) Projects";

WHEREAS, as stated in the Ordinance, MLGU Mallig will enter into a Loan Agreement with the Land Bank of the Philippines for the amount of Sixty Nine Million Pesos (Php69,000,000.00) which shall be utilized to finance the construction of Level 3 Water Systems

A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 15-2022 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF MALLIG, ISABELA AS INTRA VIRES

in the barangays of San Jose Norte, Siempre Viva, and Maligaya-Victoria, all in Mallig, Isabela, and to finance its equity for the implementation PRDP projects particularly the concreting of Barangays San Pedro, Siempre Viva Norte and Sitio Cuntapay in Trinidad, Mallig Isabela Farm-to-Market Road;

WHEREAS, Section 297(a) of the Local Government Code allows local government units to contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation, or maintenance of public facilities, infrastructure facilities and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

WHEREAS, this Honorable Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus have the best position to identify the programs, projects, and activities that will further the welfare of their people;

WHEREAS, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to MLGU Mallig Municipal Ordinance No. 15-2022, this Honorable Body finds that the said ordinance is a valid exercise of the legislative powers of their sanggunian and within the authority of MLGU Mallig as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

WHEREFORE, upon motion of Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 15-2022 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF MALLIG, ISABELA AS INTRA VIRES

RESOLVED FINALLY, that a copy of this Resolution be furnished to MLGU Mallig, Isabela officials, namely: Honorable Mayor Engr. Jose P. Calderon, and Honorable Vice Mayor Dr. Diosdado B. Felipe, for their guidance and information.
