WHEREAS, it is the policy of the State to protect and promote the health of the people;

WHEREAS, in pursuit of such policy, the National Government allocated significant amounts in the 2021 General Appropriations Act for the implementation Medical Assistant to Indigents Program (MAIP);

ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT FOR THE IMPLEMENTATION OF THE MEDICAL ASSISTANCE TO INDIGENT PATIENTS IN CAUAYAN DISTRICT HOSPITAL, PALANAN STATION HOSPITAL, AND ECHAGUE DISTRICT HOSPITAL

WHEREAS, the DOH – Cagayan Valley Center for Health Development (DOH-CVCHD) was granted by the National Government with funds for the implementation of the MAIP;

WHEREAS, the DOH-CVCHD endeavors that MAIP benefits be made available to the indigent and poor patients in the Province of Isabela. Towards this end, the DOH-CVCHD has selected Cauayan District Hospital, Palanan Station Hospital, and Echague District Hospital – all of which are owned and operated by the Provincial Government of Isabela – as implementation sites of the MAIP;

WHEREAS, submitted for the consideration of this Honorable Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and DOH-CVCHD which will make the MAIP accessible to the indigent and poor patients of the three hospitals stated in the previous clause;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, after careful perusal, this Honorable Body determined that the proposed Memorandum of Agreement between the Provincial Government of Isabela and DOH-CVCHD is just and lawful, and will improve the Isabeleño's capacity to access quality healthcare services;

WHEREFORE, upon motion of Honorable Emmanuel Joselito B. Añes, duly seconded and unanimously approved by the members present in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
