A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2021-421 (SUPPLEMENTAL BUDGET NO. III-2021) IN THE AMOUNT OF THREE MILLION THREE HUNDRED FOURTEEN THOUSAND SIX HUNDRED EIGHTY EIGHT PESOS (P3,314,688.00) OF THE CITY OF CAUAYAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 2021-421, an Ordinance authorizing Supplemental Budget No. III, S. of 2021, appropriating the amount **THREE MILLION THREE HUNDRED FOURTEEN THOUSAND SIX HUNDRED EIGHTY EIGHT PESOS (P3,314,688.00)** from the share of the City of Cauayan, Isabela on the collection of Burley and Native Tobacco Excise Tax for FY 2017, was submitted to this office for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2021-421 of the City of Cauayan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The utilization of the projects to be funded from the Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2017 amounting to Three Million Three Hundred Fourteen Thousand Six Hundred Eighty Eight Pesos (3,314,688.00) shall adhere with the provisions of LBM No. 81, dated November 4, 2020 on the Guidelines on the release and utilization of the shares of LGUs from the FY 2017 collections of Excise Tax on locally manufactured Virginia-type cigarettes under Republic Act No. 7171, and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the allocations to LGUs under the FY 2019 General Appropriations Act, Republic Act No. 11260.
2. The appropriation for the following account should be properly classified to specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:

3. That the Supplemental Annual Investment Plan shall use the prescribed BOM 2016 format (refer to page 208);
4. The proposed projects shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the Sangguniang Panlungsod of the City of Cauayan, Isabela through the **Honorable LEONCIO A. DALIN JR.**, City Vice Mayor, and **Honorable BERNARD FAUSTINO M. DY**, City Mayor.
