WHEREAS, the Health Facility Enhancement Program (HFEP) is a program being implemented by the Department of Health (DOH) to achieve the country's overall health system goals by upgrading the health facilities in the country through the provision of medical and laboratory equipment;

WHEREAS, the main objectives of the HFEP are as follows: (1) To improve the primary health facilities and to deliver effective health care services; (2) To improve the quality of Local Government Unit hospitals to comply with the DOH licensing and PhilHealth accreditation requirements. and; (3) To decongest DOH hospitals to be able to provide affordable quality tertiary care and specialized treatment;

ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF DONATION WITH THE DEPARTMENT OF HEALTH – CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT FOR THE RECEIPT OF DONATION FROM THE LATTER CONSISTING OF CASH AMOUNTING TO EIGHT HUNDRED FIFTEEN THOUSAND PESOS (PHP815,000.00) AND VARIOUS TYPES OF MEDICAL EQUIPMENT TO BE DEPLOYED IN GOVERNOR FAUSTINO N. DY SR. MEMORIAL HOSPITAL

WHEREAS, the Department of Budget and Management has released funds from the HFEP to the Department of Health Region 02;

WHEREAS, utilizing such funds and in furtherance of the objectives of HFEP, the Department of Health Region 02 undertook to donate cash and various types of medical equipment to Governor Faustino N. Dy Sr. Memorial Hospital;

WHEREAS, such donation consists of:

(a) cash amounting to Eight Hundred Fifteen Thousand Pesos (Php 815,000.00); and (b) various types of medical equipment as follows:

one (1) unit of an Autoclave, 50L;
one (1) unit of a Heavy Duty Automatic Film Processor;
one (1) unit of a Biomedical Refrigerator;
one (1) unit of a Delivery Table with a 4-5 inches Mattress and Detachable Stirrups;
one (1) unit of an Electrocardiograph (ECG) Machine with Analyzer;
ten (10) units of a 50L Oxygen Tank with Holder and Therapy Set;
ten (10) units of a Desk Type Sphygmomanometer Set;
one (1) unit of a 2L Suction Machine; and
three (3) units of Wheeled Stretcher with Mattress;

WHEREAS, the Governor Faustino N. Dy Sr. Memorial Hospital is a hospital that is owned and operated by the Provincial Government of Isabela (PGI);

WHEREAS, the PGI's acceptance of the donations described above require the execution of a Deed of Donation between the PGI and the Department of Health - Cagayan Valley Center for Health Development;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Deed of Donation between the PGI and Department of Health - Cagayan Valley Center for Health Development which will execute the above-described donation;

WHEREAS, under Section 465, (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of authority by the Sangguniang Panlalawigan;

WHEREAS, after careful review, this Honorable Body deems the Deed of Donation between the PGI and Department of Health – Cagayan Valley Center for Health Development to be beneficial and advantageous to the Province and promotive of the welfare of Isabeleños;

WHEREFORE, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
