ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH, MANUEL A. ROXAS DISTRICT HOSPITAL, DR. JOSE FABELLA MEMORIAL HOSPITAL, AND DR. RONA VICTORIA B. CRUZ FOR THE IMPLEMENTATION OF THE POST-RESIDENCY RETURN SERVICE PROGRAM**

**WHEREAS**, to further improve the medical and healthcare capabilities of the Provincial Government of Isabela (PGI) and to ensure the availability of skilled health professionals who can deliver quality healthcare services in poor and underserved areas, it aspires to enter into a Memorandum of Agreement with the Department of Health (DOH) for the deployment of medical professionals to the Province of Isabela who will provide basic healthcare services to Isabeleños;

**WHEREAS**, the DOH recognizes the need of the PGI for additional medical professionals to augment its capacity to extend effective healthcare to its people. As such, the DOH commits to deploy physicians who recently finished their residency training program in PGI hospitals who shall function as medical human resource complements;

**WHEREAS**, pursuant to the requirements of Administrative Order No. 2015-0021 and the mandates set forth in its Post-Residency Return Service Program, the DOH aspires to deploy a physician in Manuel A. Roxas District Hospital, in the person of Dr. Rona Victoria B. Cruz of Dr. Jose Fabella Memorial Hospital, to augment the medical human resource requirement in the Province of Isabela;

**WHEREAS**, the implementation of the Post-Residency Return Service Program and the deployment of Dr. Rona Victoria B. Cruz in Manuel A. Roxas District Hospital requires the execution of a Memorandum of Agreement between the PGI, DOH, and other necessary parties;

**WHEREAS**, submitted for the review and consideration of this Honorable Body is the draft Memorandum of Agreement between the PGI, DOH, Manuel A. Roxas District Hospital, Dr. Rona Victoria B. Cruz, and Dr. Jose Fabella Memorial Hospital for the implementation of the Post-Residency Return Service Program and the deployment of Dr. Rona Victoria B. Cruz in Manuel A. Roxas District Hospital;

**WHEREAS**, Section 465, (b) (vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

**WHEREAS**, after careful review, this Honorable Body deems it advantageous to the PGI to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement;

**WHEREFORE**, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
