ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT FOR THE GRANT OF ONE COVID-19 ALLOWANCE TO QUALIFIED HEALTHCARE AND NON-HEALTHCARE WORKERS IN THE PROVINCE OF ISABELA

WHEREAS, the Provincial Government of Isabela acknowledges the great efforts and sacrifices of the public and private healthcare workers and non-healthcare workers who dutifully rendered their service to respond in the management of the unprecedented crisis brought about by the Covid-19 pandemic;

WHEREAS, the National Government appropriated funds under the General Appropriations Act for Fiscal Year 2022 for the grant of benefits and incentives to the health sector personnel, including the grant of One COVID-19 Allowance (OCA);

WHEREAS, the OCA serves as an incentive to health and non-health workers of the public and private sector for their invaluable service and contribution to the country's successful management of the COVID-19 pandemic;

WHEREAS, the Department of Health and Department of Budget and Management jointly issued Administrative Order No. 2022-0001 which established the guidelines for the grant of OCA to healthcare and non-healthcare workers;

WHEREAS, in line with the aspiration of the Provincial Government of Isabela that its health sector personnel are provided with their rightful benefits and incentives, it endeavors to enter into a Memorandum of Agreement with the Department of Health – Cagayan Valley Center for Health Development to pave the way for the grant of OCA to its healthcare and non-healthcare workers;

WHEREAS, presented before this Honorable Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and the Department of Health for the grant of OCA to qualified healthcare and non-healthcare workers of the PGI;

WHEREAS, Section 465 (b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, after careful review of such Memorandum of Agreement, this Honorable Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the MOA on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT (DOH-CVCHD) FOR THE GRANT OF ONE COVID-19 ALLOWANCE.
