ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT (DOH-CVCHD) FOR THE GRANT OF COVID-19 SPECIAL RISK ALLOWANCE TO QUALIFIED PERSONNEL OF THE PROVINCIAL GOVERNMENT OF ISABELA

WHEREAS, the Provincial Government of Isabela upholds a time-honored policy in which it commits to providing its personnel all appropriate and necessary assistance for the promotion of their welfare, and all lawful incentives in order to raise their morale and productivity;

WHEREAS, pursuant to Republic Act No. 11494 or the Bayanihan to Recover as One Act, the National Government appropriated funds for the grant of COVID-19 Special Risk Allowance (SRA) to qualified public and private healthcare workers;

WHEREAS, the Department of Budget and Management (DBM) released Special Allotment Release Order No. BMB-B-22-0000196 to cover the funding needs for the proper implementation of the grant of COVID-19 SRA to eligible public and private healthcare workers;

WHEREAS, the DBM and the Department of Health jointly issued Joint Circular No. 1, Series of 2021 which established the guidelines on the Continued Grant of COVID-19 SRA to Public and Private Healthcare Workers;

WHEREAS, in line with the aim of the Provincial Government of Isabela that its personnel, especially its personnel in the health sector, are provided with their rightful benefits, it aspires to enter into a Memorandum of Agreement with the Department of Health – Cagayan Valley Center for Health Development for the grant of COVID-19 SRA to qualified healthcare workers of the PGI;

WHEREAS, submitted for the consideration of this Honorable Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela (PGI) and DOH-CVCHD that paves the way for the grant of COVID-19 SRA to qualified healthcare workers of the PGI;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, after careful review of the proposed Memorandum of Agreement, this Honorable Body finds that it is beneficial and advantageous to the Province to grant the Provincial Governor the necessary authority to sign such a MOA on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
