WHEREAS, the Provincial Government of Isabela upholds a policy in which it accords preferential consideration to the continued development of the health sector, particularly the enhancement of its capacity to provide effective medical services to the people, in the formulation of its programs and projects;

WHEREAS, the Provincial Government of Isabela recognizes the invaluable role of the field of midwifery and the midwifery professionals in promoting the Isabeleños' reproductive health, especially in providing much-needed medical attention and support to childbearing women;

WHEREAS, the Isabela State University – City of Ilagan Campus, a lawfully recognized sub-campus of Isabela State University, offers and maintains a midwifery program under its School of Midwifery;

WHEREAS, to further its health-related policies, the Provincial Government of Isabela aspires to partner with the Isabela State University for the purpose of enhancing the competence and competitiveness of the local midwifery sector by providing the students of Isabela State University – City of Ilagan Campus, School of Midwifery with necessary technical assistance;

WHEREAS, such necessary technical assistance covers the granting of access to PGI medical facilities and equipment to provide the midwifery students with an opportunity to complement their formal education with practical knowledge and skills and to gain hands-on midwifery experience from a reputable institution;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Contract of Affiliation between the Provincial Government of Isabela and Isabela State University relative to the subject referred to in the two previous clauses;

WHEREAS, after careful review, this Honorable Body deems the Contract of Affiliation between the Provincial Government of Isabela and Isabela State University to be just, lawful, and promotive of the health policies of the PGI;

WHEREAS, Section 465 (b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –


