WHEREAS, the Provincial Government of Isabela upholds a policy in which it provides the youth with genuine opportunities for meaningful and impactful participation in its policy formulation and decision-making processes;

WHEREAS, in line with its policies to promote and protect the environment and to integrate the youth into its public service initiatives, the Provincial Government of Isabela actively engages the youth sector in the implementation of its environmental protection programs, including its solid waste management and reforestation projects;

WHEREAS, the Provincial Government of Isabela aspires to improve its environmental preservation and protection capacities. As such, in partnership with the Provincial SK Federation through their Sangguniang Kabataan Para sa Kalikasan, it endeavors to collaborate with the DENR and the DILG to strengthen its solid waste management programs and reforestation project;

WHEREAS, submitted for the approval of this August Body is a proposed Memorandum of Partnership between the PGI, the DENR, and the DILG for the attainment of the environmental protection and preservation aspirations of the PGI as provided in the previous clause;

WHEREAS, Section 465(b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of authority by the Sangguniang Panlalawigan;

WHEREAS, after careful review of the submitted proposed Memorandum of Partnership, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the same on behalf of the Provincial Government of Isabela;

WHEREAS, upon motion of Honorable Marco Paolo A. Meris, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T.
