WHEREAS, presented before this August Body is the proposed Deed of Donation between the PGI and MLGU Quezon, Isabela concerning the donation of the above-described utility vehicle from the PGI in favor of MLGU Quezon, Isabela;

WHEREAS, Section 465(b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of authority by the Sangguniang Panlalawigan;

WHEREAS, Section 18 of the Local Government Code also empowers local government units to apply their resources and assets for productive, developmental, or welfare purposes, in the exercise or furtherance of their governmental powers and functions;

WHEREAS, after careful review of the Deed of Donation and in due consideration to the approval thereto of the Provincial Governor and the favorable action of the Provincial Legal Office, this August Body deems the request of the Provincial Governor to be just, lawful, and in line with the policies of the PGI on the extension of timely and responsive services to their people hence it is beneficial for the Province of Isabela to grant the Provincial Governor the necessary authority to sign the said Deed of Donation on behalf of the PGI;

WHEREFORE, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T.
