A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE AGRICULTURAL TRAINING INSTITUTE – REGIONAL TRAINING CENTER 02 FOR THE IMPLEMENTATION OF THE “SWINE AI SA BARANGAY” PROJECT IN THE PROVINCE OF ISABELA

WHEREAS, the Provincial Government of Isabela upholds a policy in which it accords preferential consideration to the development of the local agriculture sector and the welfare of its farmers in the formulation of its policies and the implementation of its programs;

WHEREAS, in furtherance of this policy, the Provincial Government of Isabela actively pursues the establishment of partnership engagements with institutions that will benefit the local agriculture sector and local farmers;

WHEREAS, the African Swine Fever (ASF), a highly infectious and deadly viral disease affecting both domestic and feral swine of all ages, swept through farms across the country causing a sudden loss of livelihood to those in the swine raising industry, the rapid depletion of local pork supplies, and an increase in the prices of pork and other pig-derived products;

WHEREAS, the Department of Agriculture is the lead government agency tasked with the implementation of State policies, programs, and projects relative to the promotion of agriculture;

WHEREAS, in line with its mandate and to address concerns regarding the situation of the swine raising industry, the Department of Agriculture launched the Integrated National Swine Production Initiatives for Recovery and Expansion Program (INSPIRE) to implement calibrated repopulation to recover the sector’s capacity to locally produce a sufficient supply of hogs and pork;

WHEREAS, the Agricultural Training Institute – Regional Training Center 02 is the capacity-building arm of the Department of Agriculture in the Cagayan Valley Region. Its mandate includes the extension of training, resources, and technical assistance in the implementation of Department of Agriculture projects and programs to local government units and other clientele;

WHEREAS, the Department of Agriculture has identified the Cabagan Breeding Station of the Provincial Government of Isabela as a beneficiary of its “**Swine AI sa Barangay**” Project. Through this project, the Provincial Government of Isabela will receive swine repopulation resources from the Agricultural Training Institute – Regional Training Center 02, including the extension of training, livelihood, food, and income to farmers and benefitting communities;

WHEREAS, the Provincial Government of Isabela and the Agricultural Training Institute – Regional Training Center 02 came into favorable terms regarding the implementation of the Swine AI sa Barangay Project at the Cabagan Breeding Station;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and the Agricultural Training Institute – Regional Training Center 02 regarding the implementation of the Swine AI sa Barangay Project at the Cabagan Breeding Station with a concomitant letter stating the request of the Provincial Governor that he be granted with authority to sign the same on behalf of the Provincial Government of Isabela;

WHEREAS, after careful review, this August Body determines the Memorandum of Agreement to be just and lawful and that granting the Provincial Governor the necessary authority to sign the same on behalf of the Provincial Government of Isabela is beneficial to Isabeleños and promotive of their welfare, and furthers the Province’s goals relative to the advancement of the local agriculture sector;

WHEREAS, Section 465(b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of authority by the Sangguniang Panlalawigan;
