WHEREAS, the Isabela State University – City of Ilagan Campus, a lawfully recognized sub-campus of Isabela State University, offers and maintains a nursing program under its School of Nursing;

WHEREAS, to further its health-related policies, the Provincial Government of Isabela aspires to partner with the Isabela State University for the purpose of enhancing the competence and competitiveness of the local nursing sector by providing the students of Isabela State University – City of Ilagan Campus, School of Nursing with the necessary technical assistance;

WHEREAS, such necessary technical assistance covers the granting of access to PGI medical facilities and equipment to provide the nursing students with an opportunity to complement their formal education with practical knowledge and skills and to gain hands-on nursing experience from a reputable institution;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Contract of Affiliation between the Provincial Government of Isabela and Isabela State University relative to the subject referred to in the two previous clauses;

WHEREAS, after a careful review, this Honorable Body deems the Contract of Affiliation between the Provincial Government of Isabela and Isabela State University to be just, lawful, and promotive of the health policies of the PGI;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents relative to the execution of his functions, upon authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T.
