**WHEREAS**, it is the policy of the Provincial Government of Isabela to protect and promote the welfare of its populace, wherever they may be;

**WHEREAS**, in line with this policy, the PGI has established satellite offices in far flung areas in the Province in order to make its programs readily available and its services more accessible to all Isabeleños;

**WHEREAS**, as considerable number of Isabeleños in Metro Manila, a good number of which are searching for gainful employment opportunities, the PGI wishes to extend its programs and services to such Isabeleños, considering that they are more susceptible to mistreatments and more vulnerable to other forms of exploitations;

**WHEREAS**, in this light, the Provincial Governor established a PGI satellite office in a rental property, which is owned by Ms. Rina S. Reyes, and is situated at #16 Kayumanggi Street, West Triangle Homes, Quezon City, Metro Manila for the establishment of the Isabela Action Center;

**WHEREAS**, the Center provides aid to individuals or families in crisis situations such as, but not limited to, medical and burial assistance, ambulatory service for patients and transporting of cadaver;

**WHEREAS**, as the Contract of Lease previously entered into by the Provincial Governor will soon lapse on September 9, 2022, the PGI is desirous to renew such agreement to ensure the extension of assistance to Isabeleños in Metro Manila remains unhampered;

**WHEREAS**, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

**WHEREAS**, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Contract of Lease on behalf of the Provincial Government of Isabela;

**WHEREAS**, premises considered, upon motion of Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled, it was –
